Thank you for submitting the capacity analysis for subject water system. The documents were prepared by your engineer, Jeff Tasoff, PE and received in our office on February 4, 2019 with additional information on February 25, 2019.

The capacity analysis for the subject water system was reviewed and, in accordance with the provisions of WAC 246-290 is **APPROVED**. The approval issued herein is only valid as it relates to current standards outlined in WAC 246-290, effective January 14, 2017. Future revisions in the rules may be more stringent and require facility modifications or corrective action.

Project summary: The report identifies the total number of platted (or potentially platted) as 100 lots in the Deception Park View Water System service area. The capacity analysis shows that the source and storage is adequate to serve the full-build out of the water system. Deception Park View currently serves 65 residential connections. This analysis was based on a maximum day demand of 450 gpd/ERU. The limiting factor is source capacity.

This approval does not provide any guarantee and should not be considered to provide any guarantee concerning legal use of water or any subsequent water right decisions by Ecology. Our approval of your project report does not confer or guarantee any right to a specific quantity of water. The approved number of service connections is based on your representation of available water quantity. If the Washington Department of Ecology, a local planning agency, or other authority responsible for determining water rights and water system adequacy determines that you have use of less water than you represented, the number of approved connections may be reduced commensurate with the actual amount of water and your legal right to use it.
