Community Notifications

We have received numerous complaints about residents parking on or partially parking on the street. We consulted Island County Public Works for our course of action since this is not directly addressed in our covenants at this time.

The following is the **WA State Law** that prohibits this activity: RCW 46.61.560 Stopping, standing, or parking outside business or residence districts. (1) Outside of incorporated cities and towns no person may stop, park, or leave standing any vehicle, whether attended or unattended, upon the roadway.

We do understand that sometimes it might be necessary to have visitors park on the roadway due to parties and/or gatherings. However, we are requesting it be limited to these temporary activities.

Residents who continue to park on the roadway will be reported to WA State Patrol and receive a notification letter.

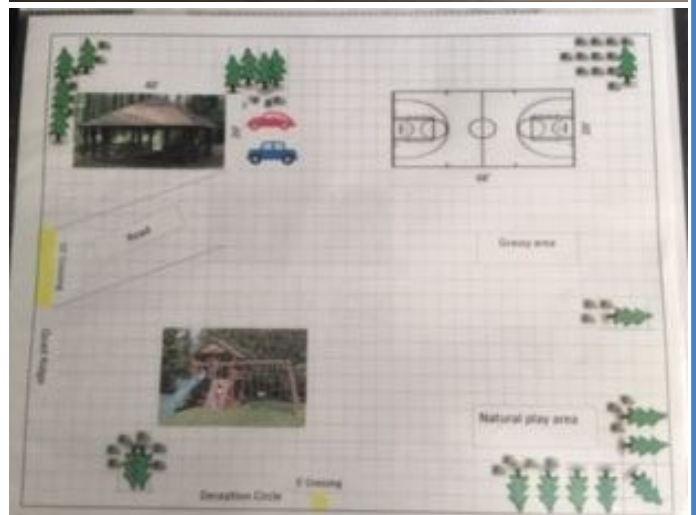
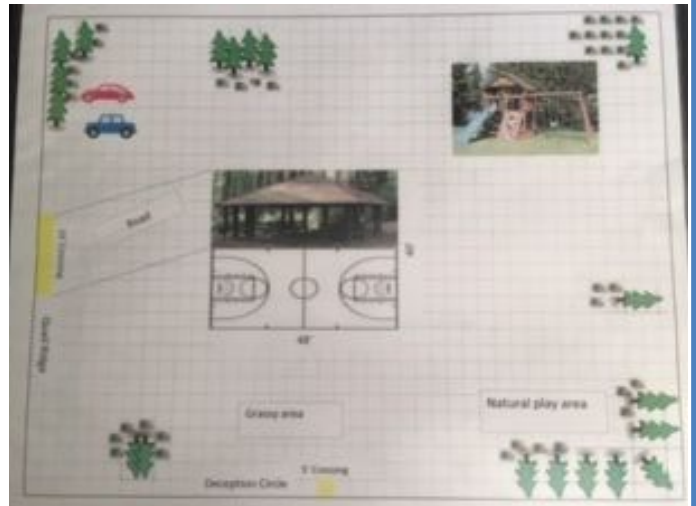
Community Park Planning Team Update
